



## PRIVACY POLICY

Sinopsys Surgical, Inc. (“Sinopsys”, “we”, “our”, “us”) values our users’ privacy. This Privacy Policy (“Policy”) will help you understand how we collect and use personal information from those who visit our website (“Site”) or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Sinopsys of our commitment and realization of our obligation to meet most existing privacy standards.

We reserve the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. If at any point in time Sinopsys decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Users at that time shall have the option as to whether to permit the use of their information in this separate manner.

### Information We Collect

Sinopsys may also deem it necessary, from time to time, to follow third party sites that our users may frequent to glean what types of services and products may be the most popular to customers or the general public.

Our Site will only collect personal information that you knowingly and willingly provide to us by way of contact forms, surveys, completed membership forms, and emails. Our Site will use personal information only for the purpose for which it was requested, and any additional uses specifically provided for in this Policy.

### **Why We Collect Information and For How Long**

We are collecting your data to:

- better understand your needs and provide you with the services you have requested;
- fulfill our legitimate interest in improving our services and products;
- send you promotional emails containing information we think you may like when we have your consent to do so;
- contact you to fill out surveys or participate in other types of market research when we have your consent to do so; and
- customize our Site according to your online behavior and personal preferences.

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; and the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

### **Use of Information Collected**

Sinopsys may collect and may make use of personal information to assist in the operation of our Site and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from <https://sinuslogic.com/>.

Sinopsys may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

Sinopsys uses various third-party social media features including but not limited to LinkedIn, Facebook, and Twitter and other interactive programs. These may collect your IP address and require cookies to work properly. These services are governed by the privacy policies of the providers and are not within our control.

## **Disclosure of Information**

Sinopsys may not use or disclose the information provided by you except under the following circumstances:

- as necessary to provide services or products you have requested;
- in other ways described in this Policy or to which you have otherwise consented;
- in the aggregate with other information in such a way so that your identity cannot reasonably be determined;
- as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of Sinopsys;
- in connection with an asset sale or purchase, a share sale, purchase or merger, bankruptcy, or other business transaction or re-organization, in our legitimate interests; and
- a prospective buyer, seller, new owner, or other relevant third party as necessary while negotiating or in relation to a change of corporate control such as a restructuring, merger, or sale of our assets.

## **Non-Marketing Purposes**

Sinopsys greatly respects your privacy. We do maintain and reserve the right to contact you if needed for nonmarketing purposes (such as bug alerts, security breaches, account issues, and/or changes in Sinopsys products and services). ## **If You are Under Legal Age**

### **Notice to European Union Users**

Sinopsys' operations are located primarily in the United States. If you provide information to us, the information will be transferred out of the European Union (EU) and sent to the United States. (The adequacy decision on the EU-US Privacy became operational on August 1, 2016. This framework protects the fundamental rights of anyone in the EU whose personal data is transferred to the United States ("US") for commercial purposes. It allows the free transfer of data to companies that are certified in the US under the Privacy Shield.)
